**Full Golf Membership** -      **\$3000.00 (single)**                      **\$5400.00 (couple)**

- Just as it sounds, a full golf membership allows unlimited use of the facilities from opening day until closing.

**Young Adult Membership** -   **\$2700.00 (single)**                      **\$4860.00 (couple)**

- Receive unlimited use of facilities from opening day until the end of the season.
- Open to those 35 years old or under as of January 1<sup>st</sup>, 2023. Those selecting this membership option must provide date of birth on application.

**Off-Peak Membership** -      **\$2000.00 (single)**                      **\$3600.00 (couple)**

- Off-Peak membership entitles full golf privileges in the off season (opening day until May 26<sup>th</sup>, 2023 and anytime starting September 11<sup>th</sup>, 2023 through the end of the season.

## TERMS OF MEMBERSHIP

1. **APPROVAL FOR MEMBERSHIP:** I understand that this application will not be acted upon unless fully completed and signed by me. Membership is contingent upon approval by the club. Approval by the club shall be in the Club's sole and absolute discretion.
2. **RECEIPT OF RULES AND REGULATIONS:** I hereby acknowledge receipt of the Rules and Regulations of the Club. I understand that my membership is governed by the Rules and Regulations; and agree to be bound to the terms and conditions thereof.
3. **MEMBERSHIP:** The Club facilities will be owned and operated by The Ledges Golf Course Company, a Maine Corporation. I hereby acknowledge that my membership in the Club is not an investment in the Club, nor does it provide an equity or ownership interest in the Club or the Club facilities. Membership does not confer upon me a vested or prescriptive right or easement to use the Club's facilities.

Members will not have any interest in the income of the Club and will not receive any of the Clubs assets if the Club is dissolved. The Club reserves the right, in its sole and absolute discretion, to modify the Membership and the Rules and Regulations, to reserve memberships, to discontinue operation of any or all of the Club's facilities, to sell or otherwise dispose of the Club's facilities in any manner whatsoever, to convert the Club to a member owned club, to restrict or to otherwise reserve the Club facilities for maintenance, golf tournaments and other special events from time to time. Membership in the Club is a revocable license, subject to suspension and revocation with or without cause. In the event of any suit between the Club and any member for any claim or matter, the prevailing party shall be reimbursed by the other party for all costs and expenses incurred in such suit, including attorney's fees (including fees required in connection with appellate proceedings).

4. **HOLD HARMLESS:** I hereby acknowledge that the use of the Club facilities and any privilege or service incident to membership is voluntary and is undertaken with knowledge of the risk of possible injury. Each member shall be liable for any property damage and/or personal injury at the Club's facilities caused by the member, or the member's guest. The costs of any such damage shall be paid by the member.
5. **GOVERNING LAW:** The Application for Membership shall be governed by and construed in accordance with the laws of The State of Maine.
6. **SEASONAL MEMBERSHIP FEE:** Seasonal membership fees are not refundable nor are they prorated under any circumstances.
7. **NO SHOW POLICY:** In the event that one or more reserved players do not show for a booked tee time the booking party will be held liable for unused slots. In such instances the liable party may be assessed a No Show Fee of \$25 per player at the discretion of The Ledges Golf Club staff.
8. **PRO SHOP CREDIT:** Credit accrued through playing in Club sponsored tournaments and leagues may only be spent on in stock Pro Shop merchandise. Remaining credit balance will expire at the conclusion of the 2023 season.
9. **PAYMENT PLAN:** I hereby acknowledge by entering this agreement with The Ledges Golf Club I agree to pay for each installment by the specified date. Down payment is required by 3/15/23 with 5 subsequent payments on the 15<sup>th</sup> of each month starting in May and ending in September. By agreeing to the payment plan, I authorize The Ledges Golf Club to automatically bill me for my selected plan using the Credit Card or ACH Payment information provided. Should payment not be completed on time I understand that the Club reserves the right to suspend all playing privileges until my account is current.
